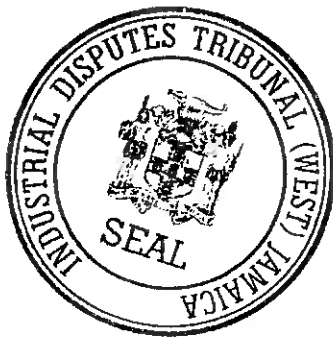

By joint letter dated November 19, 2025, the parties reiterated that the matter was settled and that the terms of the settlement reached is to be kept confidential.





AWARD


