By letter dated June 23, 2021, the Honourable Minister of Labour and Social Security in accordance with Section 11A(1)(a)(i) of the Labour Relations and Industrial Disputes Act (hereinafter called “the Act”), referred to the Industrial Disputes Tribunal for settlement the following Terms of Reference, the industrial dispute described therein:-

The Terms of Reference were as follows:

“To determine and settle the dispute between Giesecke and Devrient Currency Technology America, Inc. on the one hand, and Edson Marshall on the other hand, over the termination of his employment.”

SUBMISSIONS AND SITTINGS:

No Briefs were submitted. The parties from the onset requested time to have local level discussions with a view to settling. Notwithstanding the request, dates were set for hearing. Two (2) sittings were held between November 8, 2021 and November 22, 2021.

REPORT TO THE TRIBUNAL:

1. On the first sitting of the Tribunal on November 8, 2021, the parties asked for an adjournment to continue talks at the local level with a view to resolving the dispute. In light of this request the Tribunal agreed to adjourn the hearing until November 22, 2021, at which time the parties would report the outcome of their talks.
2. At the second sitting on November 22, 2021, the parties informed the Tribunal that there was an agreement in principle but it was not yet formalized. The parties were asked to submit a joint letter of agreement on or before December 6, 2021.

3. On December 7, 2021 the Tribunal received a joint letter dated November 6, 2021 from the parties confirming that the dispute has been fully and finally settled on confidential terms.

AWARD:

4. The parties having settled the dispute at the local level without the assistance of the Tribunal and have by way of joint letter dated December 6, 2021 (a copy of which is attached) informing the Tribunal of the settlement, it is that settlement which constitutes the Award.

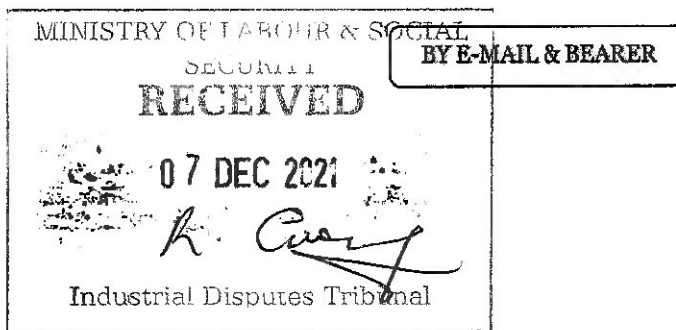
