By letter dated September 12, 2022, the Honourable Minister of Labour and Social Security in accordance with Section 11A (1) (a) (i) of the Labour Relations and Industrial Disputes Act (hereinafter called "the Act"), referred to the Industrial Disputes Tribunal for settlement in accordance with the following Terms of Reference, the industrial dispute described therein:-

The Terms of Reference were as follows:

"To determine and settle the dispute between Jamaica Fire Brigade on the one hand, and the University and Allied Workers' Union on the other hand, over the termination of the employment of Shawn Duff".

#### **SITTINGS AND SUBMISSIONS:**

- 1. The parties submitted briefs to the Tribunal and one (1) sitting was held on December 7, 2022.
- 2. Mr. Clinton Lewis died on March 8, 2023.
- In accordance with Section 8(4) of the Labour Relations and Industrial Disputes Act, Mrs. Chelsie Shellie-Vernon, Member was appointed to replace Mr. Lewis.
- 4. No sittings were held during 2023 due to circumstances beyond the control of the Tribunal.

#### **REPORT OF THE TRIBUNAL:**

 In January 2024, the Tribunal was informed that the parties were having discussions towards a settlement.



6. By letter dated May 16, 2024 (received May 17, 2024), the Attorney representing the Jamaica Fire Brigade submitted a joint settlement dated May 1, 2024 executed by the Jamaica Fire Brigade and the University and Allied Workers Union on behalf of Mr. Shawn Duff. The parties have indicated that they wish for the settlement to remain confidential.

#### **THE AWARD:**

7. The parties arrived at a settlement as stated in letter dated May 16, 2024 (copy attached). The settlement agreement is not included in the Award as the parties have asked for it to remain confidential. It is that settlement that constitutes this Award.
