REFERENCE

The Hon. Minister of Labour and Social Security, by letter dated March 8, 2022, Ref. No. A5800, has referred to the Industrial Disputes Tribunal ("IDT") for settlement the dispute between Ken Loushusan & Sons Limited t/a Loushusan Supermarket and Mr. Kevin Bennett in accordance with Section 11A (1)(a)(i) of the Labour Relations and Industrial Disputes Act, 1975 ("the Act"), with the following Terms of Reference:

"To determine and settle the dispute between Kenneth Loushusan & Sons Ltd t/a Loushusan Supermarket on the one hand and Mr. Kevin Bennett on the other hand, over the termination of his contract of employment."

SUBMISSIONS AND SITTINGS

- The Tribunal received a brief from Mr. Nicholas Kellyman representing the aggrieved worker; however, no brief was received on behalf of the Company. Schedule dates for sittings were vacated as the Tribunal, pursuant to section 12(5)(b) of the Labour Relations and Industrial Disputes Act, sought to facilitate a request from the parties for more time to engage in local level discussions with a view to arriving at a settlement.
- 2. On September 23, 2022 Mr. Kellyman, in an email to the Tribunal, advised that *"both parties were in discussions and came to an agreement which was formally executed..."* Notwithstanding the agreement he said that his client could not discontinue the proceedings because the *"discontinuance of proceedings was*

contingent on payment being made in accordance with the aforesaid formal agreement...", and up to that time his client had not received payment.

3. A sitting scheduled by the Tribunal for September 27, 2022 was cancelled at the request of counsel for the aggrieved, who requested that "...the matter be *discontinued and brought to an end...*" consequent on the settlement agreement arrived at by both parties.

PARTIES' RESPONSE

4. The Tribunal received on October 28, 2022, a joint letter from the parties dated October 5, 2022, which indicated that *"the parties have arrived at a settlement.... the terms of which are confidential,"* and as a consequence, there would be *"...no necessity for the Tribunal to schedule any further meetings in this matter."*





AWARD

5. The duly executed letter of October 5, 2022, herein attached, reflects the full participation of both parties in a settlement agreement, the terms of which have not been disclosed to the Tribunal. Accordingly, the Tribunal will discontinue proceedings and record the settlement in the form of an award.
